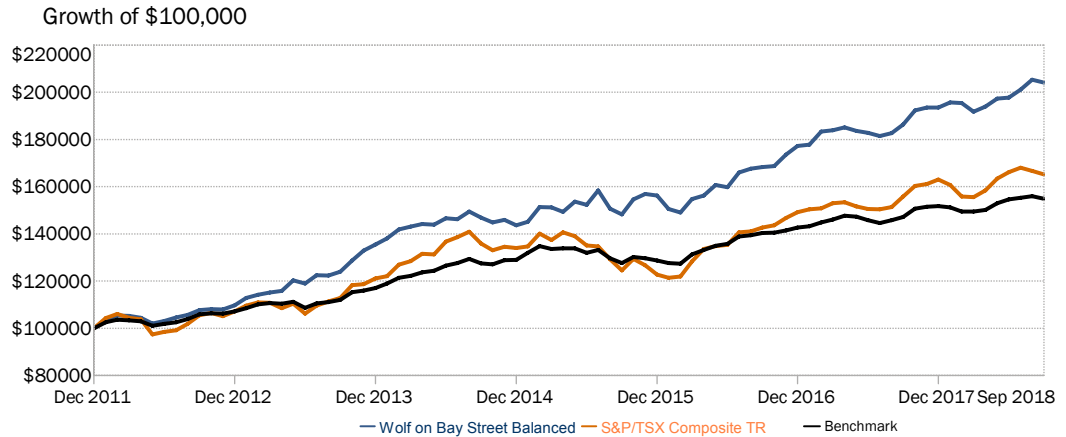

**Mandate Description**

The objective of the Wolf on Bay Street Balanced mandate is to achieve balanced returns over market cycles. The asset mix is balanced, with 60% equity and 40% fixed income. With an overall focus on capital preservation, the mandate manages risk first and capital growth second. An agnostic approach to both asset allocation and security selection drives the investment strategy, and allows the manager to identify and benefit from emerging themes in the global equity, fixed income and currency markets. The Wolf on Bay Street Balanced mandate is suitable for assets with a medium-term time horizon, generally greater than seven years, and higher volatility must be acceptable for the potential longer-term capital gains. The portfolio will invest in stocks, bonds, cash, ETFs, mutual funds and some alternative securities, allowing for a go-anywhere approach. The long-term objective of the strategy is to achieve a 7% annualized return over a full market cycle.

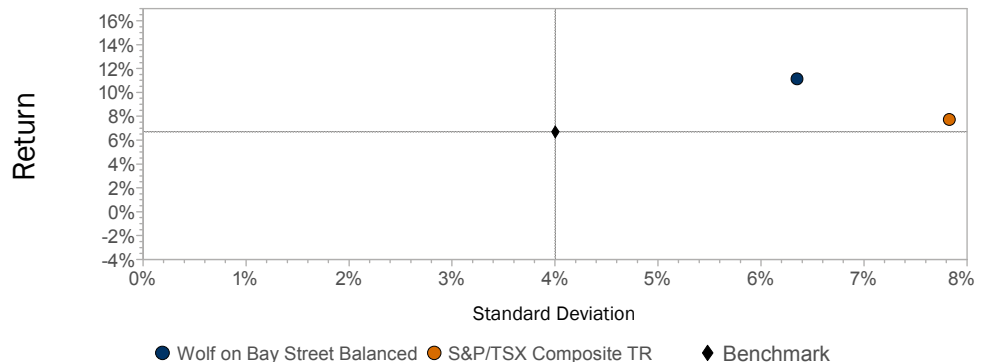

**Return vs. Standard Deviation (Risk)**

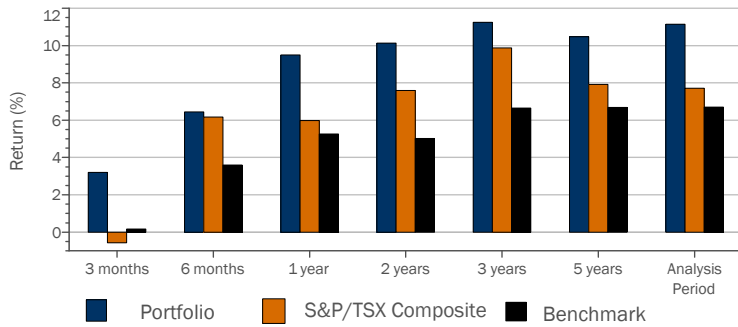

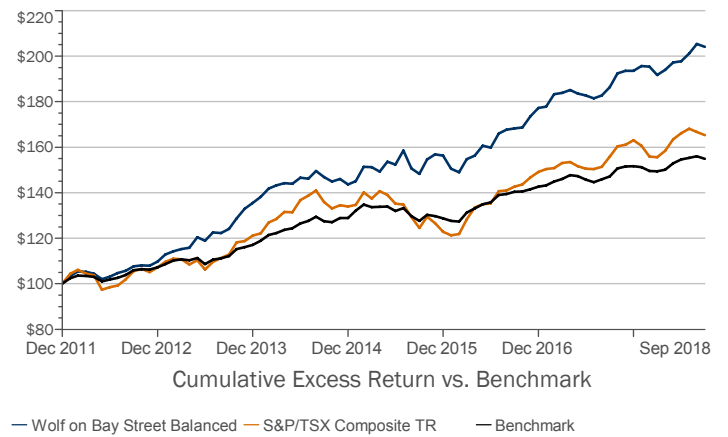
