

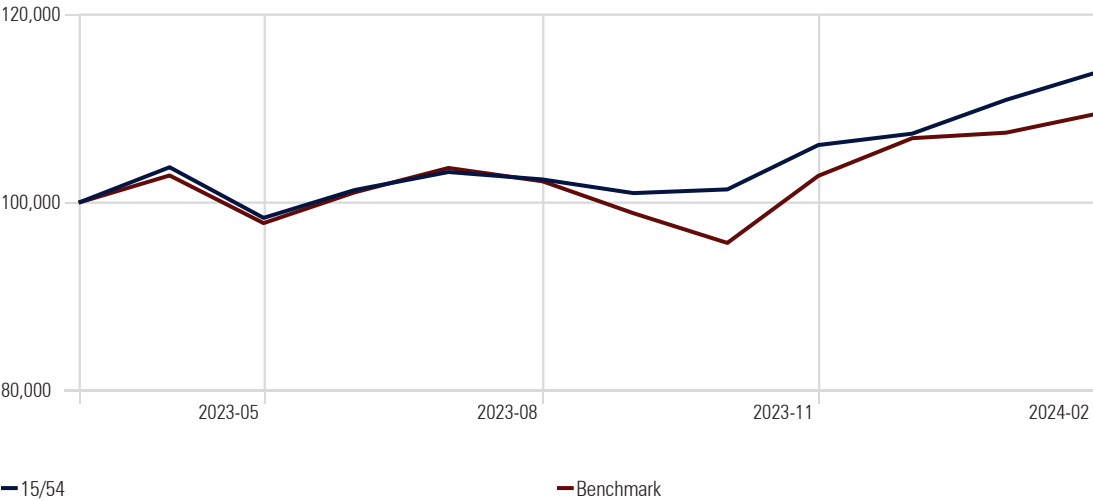

Mandate Description

The objective of the Wolf on Bay Street 15/54 is to achieve above average risk adjusted returns over a full market cycle. The portfolio is composed of large cap Canadian companies that are screened on fundamental factors and relative strength. The mandate is designed to focus on capital appreciation and long-term growth. The manager utilizes a propriety screening approach designed to remove emotion and potential biases from the security selection process. The manager maintains oversight on the portfolio and makes the final decision on all securities held in the portfolio. The Wolf on Bay Street 15/54 is suitable for investors with a longer-term time horizon, generally greater than 10 years, and higher volatility must be acceptable for the potential longer-term capital gains. The portfolio invests only in equities and is designed to beat the return of the TSX60 over a full market cycle.

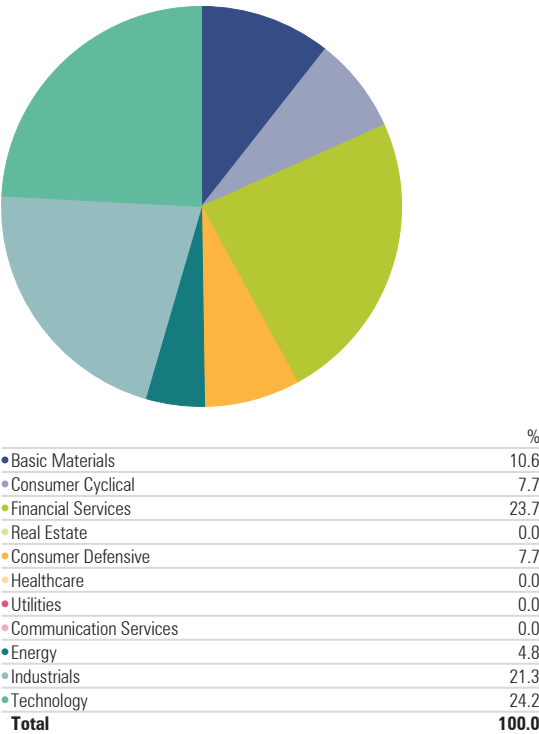

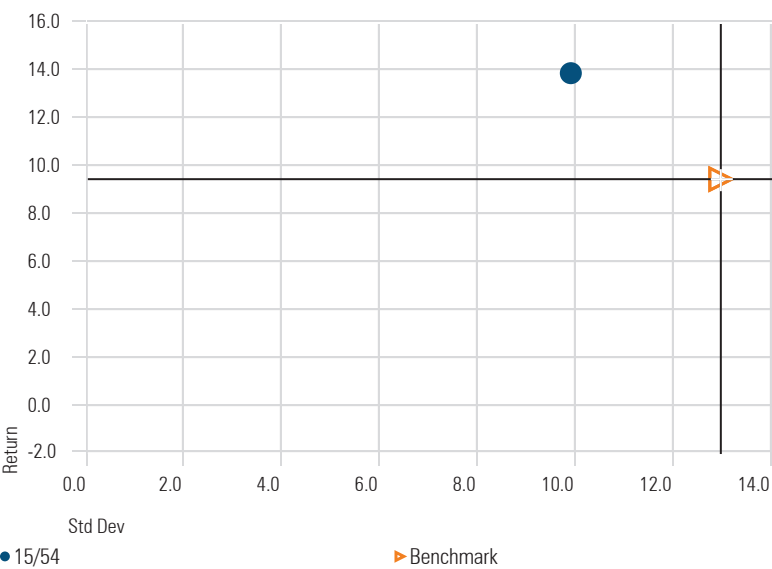
