

#### **Mandate Description**



The portfolio is composed of S&P 500 stocks that are screened on fundamental factors and relative strength. The mandate is designed to focus on capital appreciation and long-term growth. The manager utilizes a propriety screening approach designed to remove emotion and potential biases from the security selection process. The manager maintains oversight on the portfolio and makes the final decision on all securities held in the portfolio. The Wolf on Bay Street 25/101 is suitable for investors with a longer-term time horizon, generally greater than 10 years, and higher volatility must be acceptable for the potential longer-term capital gains. The portfolio invests only is equities and is designed to beat the return of the S&P500 over a full market cycle.


